- 1 Section 1. Section 3204 of the education law is amended by adding a
- 2 new subdivision 6 to read as follows:
- 3 6. Notwithstanding any law, rule, or regulation to the contrary:
- 4 (a) Instruction at a nonpublic school satisfies all the requirements
- 5 of this part applicable to instruction, including subdivision two of
- 6 this section, subdivision two of section thirty-two hundred ten of this
- 7 part, and any other requirements in this chapter applicable to instruc-
- 8 tion, and shall thereby qualify as and be finally determined to be at
- 9 least substantially equivalent to the instruction given to minors of
- 10 like age and attainments at the public schools of the city or district
- 11 where the minor resides, if such nonpublic school is:
- 12 (i) a registered high school or nonpublic school serving grades one
- 13 through eight that has a registered high school;
- 14 (ii) a state-approved private special education school or state-oper-
- 15 <u>ated or state-supported school established by the state legislature</u>
- 16 pursuant to article eighty-five, eighty-seven or eighty-eight of this
- 17 chapter;
- 18 (iii) a nonpublic school that is accredited or is awarded provisional
- 19 status by an accreditation body approved by the commissioner for
- 20 purposes of demonstrating compliance with the requirements of this
- 21 section, except that such provisional status shall only apply for the
- 22 first five years that such nonpublic school has been awarded provisional
- 23 status. An accreditation body shall have the knowledge and expertise to
- 24 properly evaluate the entirety of the day's curriculum of those schools
- 25 that it accredits and shall use a peer review process that includes
- 26 evaluation by leaders of similar nonpublic schools, appropriately train
- 27 <u>all staff and peer reviewers who are involved in the accreditation proc-</u>
- 28 ess, accredit based on publicly accessible documented standards, perform

a comprehensive onsite visit of any school seeking accreditation while 2 such school is in session, and periodically conduct a combination of interim and full accreditation reviews of the nonpublic schools which it 3 accredits during at least a ten-year period. Additionally, such accreditation body shall require nonpublic schools seeking accreditation to have curriculum that is informed by research, document individual 7 student progress, and have mechanisms for monitoring, assessing, and providing feedback on student progress. The commissioner may, at any time, revoke such commissioner's approval of an accreditation body for 10 cause, upon notice and hearing; (iv) a nonpublic school that is a middle or high school and is accred-11 12 ited or is awarded provisional status by an accreditor that is a postsecondary accreditor that is recognized by the United States department of 13 14 education for postsecondary purposes and that has at least five years of 15 experience accrediting middle or high schools under standards such accreditor has adopted for the secondary school context, except that 16 17 such provisional status shall only apply for the first five years that 18 such nonpublic school has been awarded provisional status. An accreditor 19 shall no longer meet the requirements of this subdivision upon a final 20 determination by the commissioner after notice and a hearing that the accreditor consistently fails to follow the standards established by 21 22 such accreditor; use a peer review process that includes evaluation by 23 leaders of similar nonpublic schools; appropriately train all staff and peer reviewers who are involved in the accreditation process; accredit 24 based on publicly accessible documented standards; perform a comprehen-25 26 sive onsite visit of any school seeking accreditation while such school is in session; periodically conduct a combination of interim and full 27 accreditation reviews of the nonpublic schools which it accredits during

- 1 at least a ten-year period; and require nonpublic schools seeking
- 2 accreditation to have curriculum that is informed by research, document
- 3 individual student progress, and have mechanisms for monitoring, assess-
- 4 ing, and providing feedback on student progress;
- 5 (v) a nonpublic school that participates in the international bacca-
- 6 <u>laureate program;</u>
- 7 (vi) a nonpublic school whose instruction is approved by the United
- 8 States government for instruction on a military base or service academy;
- 9 (vii) a nonpublic school in which the percentage of students who score
- 10 "proficient" on a year-end summative or cumulative assessment and taken
- 11 in the same subject areas and for the same grade levels as the annual
- 12 New York state testing program to comply with the federal Every Student
- 13 Succeeds Act is equal to or greater than one of the following metrics,
- 14 and such school has declared the intended use of such metric at the
- 15 beginning of the school year:
- 16 (1) the percentage of similarly situated public school students scor-
- 17 ing at the "proficient" level on New York state testing program tests
- 18 taken in the same subject areas and grade levels in the school district
- 19 that serves the same geographic area as the nonpublic school is located;
- 20 <u>or</u>
- 21 (2) the percentage of similarly situated public school students state-
- 22 wide scoring at the "proficient" level on New York state testing program
- 23 tests taken in the same subject areas and grade levels; or
- 24 (viii) a nonpublic school that administers a year-end summative or
- 25 <u>cumulative assessment taken in substantially the same subject areas and</u>
- 26 same grade levels as the annual New York state testing program to comply
- 27 with the federal Every Student Succeeds Act, has a three-year average
- 28 participation rate that is equal to or greater than the three-year

- 1 statewide average participation rate, and uses the results to assess the
- 2 school's educational program and to seek to improve instruction and its
- 3 <u>students' performance on such tests.</u>
- 4 (b) (i) For purposes of subparagraphs (vii) and (viii) of paragraph
- 5 (a) of this subdivision, the following terms shall have the following
- 6 <u>meanings:</u>
- 7 (1) "Year-end summative or cumulative assessment" shall mean one or
- 8 more assessments selected by the nonpublic school that qualifies as (A)
- 9 a New York state testing program test; (B) an assessment approved by the
- 10 commissioner; or (C) a nationally-recognized, commercially published
- 11 norm-referenced achievement test. All assessments and materials used in
- 12 connection with such assessments shall be culturally competent and
- 13 respectful of cultural curricula and pedagogy. A nonpublic school shall
- 14 not need to use the same year-end summative or cumulative assessment
- 15 <u>across all grades or years and may change assessments used at any time.</u>
- 16 (2) "Proficient" shall mean, as applicable, (A) a score of "profi-
- 17 cient" on a New York state testing program test; (B) a score determined
- 18 by the commissioner for an assessment approved by the commissioner; or
- 19 (C) a score of at least the thirty-third percentile on a nationally-re-
- 20 cognized, commercially published norm-referenced achievement test,
- 21 unless the commissioner approves a lower percentage for such tests.
- 22 (ii) To rely on subparagraph (vii) of paragraph (a) of this subdivi-
- 23 sion, a nonpublic school shall demonstrate a student participation rate
- 24 on its year-end summative or cumulative assessment or assessments equal
- 25 to or greater than the three-year average statewide participation rate.
- 26 (iii) To allow for adequate preparation of students in connection with
- 27 subparagraphs (vii) and (viii) of paragraph (a) of this subdivision, a
- 28 phase-in period shall be established. During such phase-in period, a

nonpublic school and its affiliated schools shall be deemed to have met 2 the criteria in subparagraphs (vii) and (viii) of paragraph (a) of this subdivision, for purposes of all components of this subdivision. Such 3 phase-in status shall commence upon the effective date of this subdivision, including prior to the administration of any year-end summative or cumulative assessment, and shall continue until the first cohort enter-7 ing second grade at such nonpublic school after such effective date completes the year-end summative or cumulative assessment for the third grade and shall further continue in the subsequent years, as long as such nonpublic school continues administering a year-end summative or 10 11 cumulative assessment for the third grade and adds one additional, higher grade each year until such nonpublic school is administering a year-12 end summative or cumulative assessment for grades three through ten. The 13 14 phase-in period shall end after the two thousand thirty-two--two thou-15 sand thirty-three school year. Prior to such cohorts tested using yearend summative or cumulative assessments under subparagraphs (vii) and 16 17 (viii) of paragraph (a) of this subdivision, such cohorts may be 18 provided with practice and/or sample testing questions to begin famil-19 iarizing themselves with standardized testing methodology. 20 (iv) For purposes of all components of this subdivision, if a nonpub-21 lic school meets any of the criteria in paragraph (a) of this subdivi-22 sion, then all affiliated schools shall be deemed to have met such 23 criteria. Affiliated schools are those with one of the following: the same office of religious and independent school support (ORISS) code 24 25 under a single basic educational data system (BEDS) code; or the same organization with a different BEDS code in the same location; or the 26 same ORISS code and leadership but may have physical buildings in 27 <u>different locations.</u>

- 1 (c) Nothing in this subdivision shall preclude the commissioner from
- 2 <u>defining by rule or regulation alternative criteria which may also be</u>
- 3 used to demonstrate that instruction at a nonpublic school is in compli-
- 4 ance with this section. Compliance with this section may be demonstrated
- 5 through any one or more of the criteria established in this subdivision
- 6 and shall constitute a final substantial equivalency determination with-
- 7 out any further requirements. A nonpublic school may elect at any time
- 8 to select different criteria. A nonpublic school's omission to satisfy
- 9 one or more criteria shall not affect a nonpublic school's ability to
- 10 <u>satisfy another</u>.
